# **Key Features and Improvements - Details**

## UX - Design - Improved UX and design of main web application

## Why is it useful?

To improve the user experience. Can help users more quickly identify where they are in the application and the most relevant sections.

#### **Details:**

Improvements include:

New login screen

Sidebar icons have different colours which are mirrored when in their associated modules.

Can select from one of three colour schemes in Settings -> General Settings.

Tabs can be pinned or hidden to only show relevant information for each user.

On the details page for assets, sites and jobs you can toggle between a simple view or a detailed view.

## Health and Safety Module - Quality Assurance - Audit Reports

## Why is it useful?

If you do audits or inspections for your clients or your own organisation or you receive audit reports from external bodies then this will help you manage them.

#### **Details:**

Create an audit report.

For the report create or upload the findings and observations.

Manage the findings and create jobs from them if required.

View the status on the Health and Safety dashboard.

## Documents - Can set a weblink / URL for new documents

#### Why is it useful?

Some of your documents may already be available on another web site. For example, on SharePoint. So now you can specify the weblink / URL to this document rather than uploading it again.

#### **Details:**

When you upload a document, you will still be able to upload it from your laptop as before. But now you will also be given the choice to specify a weblink or URL.

## Sent Emails - Can see history of all emails sent with delivery and read status

## Why is it useful?

You will not be able to see a history of all emails sent, and more importantly to see the delivery status. For example, was it received, read or was it blocked. This will be particularly important for emails sent to contractors after instructing a job.

#### **Details:**

In the settings area there is already an option "Audit Trail" which show most user actions. In here there is a new option "Emails Sent" where you can see every email sent and its delivery status.

Also, on the job task details page you will the delivery status of emails sent to the contractor for ease of use.

## Planned Maintenance – Easier to attach multiple items

## Why is it useful?

Currently when you want to attach a site or asset to a planned schedule you have to attach one item at a time and specify the resource, due date and assigned user for each one. Now you can attach multiple in one go to save time.

#### **Details:**

In the "Attached items" tab of the planned schedule page, when you attach a new item, you will see the new "Select All" button which will let you attach all the sites or assets on that page of the grid. With the filters on there, this will save you a lot of time.

# **Printing QR Codes - Paging introduced to allow easier printing**

## Why is it useful?

From the QR codes sub menu item you can choose to print all the QR codes in the grid. But this can be a problem if you have 1000s of them. Now you can print them page by page to a PDF and then print.

#### **Details:**

In assets -> QR codes you have the option to Print QR codes. This will now offer you to print just the current page you are on.
